
OVER THE RIVER.

Official Vote.—The return judges met yesterday in the court house, at twelve o'clock, to make returns of the election held in Cumberland county on Tuesday last. The following is the official result:—For Senator, William J. Bewell, Rep., received 4991 votes; Samuel P. Lippincott, Dem., received 4268; Bewell's majority, 723. For a sheriff, Jacob U. Daubman, R., received 6162; Thomas A. Wilson, D., 3435; Daubman's majority, 2727. For recorder of deeds, George W. Gilbert, R., received 5691;

John Garrett, D., 400; **Gibert's majority**, 1000. For county clerk, **Joshua Kirkbridge**, R., received 5000; **Joseph H. Garrett**, D., 3000, majority for Kirkbridge, 1800. For Assembly in the First District, **A. C. Heaverl**, R., received 1600 votes; **D. M. Chambers**, D., 1200; **Scovel's majority**, 500. In the Second District, **Oliver Lund**, R., received 3000 votes; **William H. Grimes**, D., 1200; **Lund's majority**, 400. In the Third District, **Richard N. Hartree**, R., received 1600 votes; **Van Buren Giffen**, Democrat, 1200; majority for Herring, 300. For governor in the First District, **Papenfuss Roberts**, R., received 3100 votes; **Joseph S. Collins**, D., 4000; **Roberts' majority**, 1400. In the Second District, **William Thompson**, R., received 5000 votes; **Albert Fish**, D., 4000; **Thompson's majority**, 1000. In the Third District, **James W. Blake**, D., received 5000 votes; **Richard Woodrow**, D., 3000; majority for Blake, 2000. In Merchantville there were 75 votes cast, every one of which were for Mr. Lund, Republican candidate for the Assembly in the Second Legislative District.

The Game Law—On the 1st instant the Game law in reference to the shooting and capturing of quail, partridges and rabbits went into operation, and it is now lawful to shoot them until the 1st of January. The following section of the act incorporating the West Jersey Game Protective Society explains the conditions—“Any person or persons, non-residents of this State, wishing to kill, destroy, hunt or take at any time any game as provided for in the seventh section of the Act incorporated this society shall first become members, by payment of the membership fee (\$5) to the secretary.” After the 1st of January, 1870, the fee will be \$2, instead of \$3 per annum, to non residents of the State. The money raised by fees is appropriated toward clearing the woods and streams with game. The amount expended this year is \$1000. By law every member of the society is invested with police powers and can arrest any person who violates the law.

All Dangerous—Yesterday Robert Todd, Jr., who was dreadfully beaten over the head with a bludgeon, on Thursday morning, was still in a dangerous condition, and it was not believed that he could recover. He was able to talk a little. In view of this it was deemed advisable to take his ante mortem statement. He testified that he recognized the colored man, Eldridge, and Constable Haan. He was in the act of turning the switch at Second street and Bridge avenue, and advised them to get out of the way, so as not to be hurt by the car. He could not recollect anything more. Haan, Paul, Linkford and Eldridge are still in jail, awaiting the result of his injuries. The wounded man complains of great pain in and about his head.

Sunday School Convention—The annual convention of the Camden County Sunday School Association closed its sessions last evening. Thirty schools were reported in a prosperous state, and the various workings of the association were represented to be satisfactory. The following officers were elected:—President, Rev. F. R. Bishop; corresponding secretary, J. Earl Atkinson; assistant corresponding secretary, Walter M. Patton; city secretary, B. W. Pierce. Several of the schools have had a handsome increase during the year.

The Revivalists—The proposition to secure the services of the great evangelists, Moody and Sankey, for a short season in Camden, is meeting with much favor. It is thought that a formal invitation will be extended to them by the various evangelical churches during their stay in Philadelphia.

Camden Markets—During the past week 28 loads of hay were disposed of in the Camden market, at \$1.10@1.20 @ 100 lbs.; 35 loads of straw at \$1.00@40c. In the calf market 125 head were sold at 70cts. @ 100 lbs.; 140 sheep at \$2@1; 20 head of lambs at 24@5c. @ 100 lbs., according to quality.
